- Support and activities by all stakeholders

**Title: Way forward** 

111. Delegations noted the need to manage chemicals within the entire lifecycle. They called for speeding up the process of addressing the problem of obsolete pesticides that threaten the health of millions of people and the environment, which is a result of unsound chemicals management and pesticide overconsumption. It was highlighted that integrated pest management can reduce application of chemicals in agriculture.

Title of the Chair's Summary: Way forward

115. It was emphasized that the health sector should play a more active role in sound chemicals management, for example by availing of WHO offices to offices to strengthen coordination at the national and regional levels.



# WHAT NEEDS TO BE DONE?

Use the existing instrument

#### **Resolution OPC:**

- Immediately beginn with its implementation.
- PRIORITIZE the issue of obsolete pesticide in the national development plans
- Establish cooperation, preparation of the strategy, common use of financial sources (biletarel and multilateral cooperation).



# WHAT NEEDS TO BE DONE?

#### **Make efforts**

- a) Danube Strategy: include the topic of the obsolete pesticides and other obsolete chemicals in the strategy (implementation of the Resolution OPC)
- b) CSD: prepare decision of 19. Session
- c) Rio+20: bring the topic to the conclusions of the meeting.



# WHAT NEEDS TO BE DONE?

- •Establish partnership among the Danube countries in the project of obsolete pesticides.
- Potential partners all Danube countries:

eight EU members (Germany, Austria, Czech Republic, Slovak Republic, Hungary, Slovenia, Romania, Bulgaria)

six non-members of the EU (Croatia, Serbia, Bosnia & Herzegovina, Montenegro, Moldavia, Ukraine).



### **CONCLUSION:**

Prioritization of the issue on the national level.
Use existing national and international legal and financial instruments, like ENPI, GEF
Develop/support further documents/instruments and plans at all levels

Danube strategy could be one of them, followed by decision on CSD and Rio-20, use existing and look for additional financial instruments.
